## MINUTES

REGULAR MEETING  
AUGUST 16, 2017

THE MEETING WAS BROUGHT TO ORDER AT 1805.  
MINUTES FROM JUNE 21, 2017 WERE APPROVED.  
AGENDA APPROVED  
JULY MEETING WAS CANCELLED TO HEALTH PROBLEMS OF THE PORT DIRECTOR.

MEETING STARTED AND THE DIRECTOR SHARED SOME DETAILS ON HER HEALTH. THE COMMUNITY WAS INTERESTED IN WHO WAS GOING TO BE HIRED IN THE DIRECTOR'S PLACE WHILE SHE IS OUT. IT WAS STATED THAT SHE WOULD NOT BE OUT OR UNABLE TO DO HER JOB. THERE WERE A LOT OF QUESTIONS BEING ASKED AND THE COMMISSION SAID IT WILL NOT BE ADDRESSED AT THIS TIME AND DETAILS WILL BE HANDELED AS NEEDED.

IT WAS ASKED BY THE COMMUNITY WHY THE DIRECTOR'S TIMESHEETS WERE NOT AVAILABLE ON LINE. THE ANSWER FROM THE COMMISSION AND DIRECTOR WAS THAT IT IS NOT A NORMAL PRACTICE TO PUT THESE ON OUR WEBSITE BUT THEY ARE PUBLIC RECORD AND CAN BE OBTAINED WITH A PUBLIC RECORD REQUEST.

ONE OF THE MEMBERS OF THE COMMUNITY THAT WAS ASKING QUESTIONS STARTED TO ADD CONCERN TO HER QUESTIONS. DIRECTOR KROTZER BECAME VERY EMOTIONAL AND EXPRESSED HER DISBELIEF OF HOW THE CERTAIN PERSON WAS ACTING, USING A COUPLE OF CHARGED WORDS SHE WAS HELPED INTO THE OFFICE BY COMMISSIONER MCLEAN, SHE WAS OFFICIALLY EXCUSED FROM THE MEETING BY THE COMMISSION. WHEN THE MEETING RESUMED WITH COMMISSIONER MCLEAN IN HER SEAT, SHE SAID "YOU GUYS ARE ON A HEAD HUNT AND IT IS NOT FAIR" THE REPLY FROM ONE COMMUNITY MEMBER WAS "MORE LIKE A WITCH HUNT".

THE REST OF THE NEW BUSINESS WAS TABLED FOR LATER DISCUSSION.  
MEETING WAS ADJOURNED AT 1910.
